# **Course Description:**

The AS Sustainability Center exists to ignite a passion in the campus community to be active in protecting and restoring the earth. We do this by researching, imagining, and creating solutions that address environmental and cultural problems. The overall goal of the internship program is to offer students the opportunity to engage in student driven and action oriented projects and activities. Throughout the semester, students will work directly with a program staff member to implement the goals of a specific initiative, participate in the broader activities of the Sustainability Center, and see a project through from start to finish. Students will choose one of six focus options for their internship.

This syllabus is based on a one-unit internship (45hours/semester). Two unit (90hours/semester) and three unit (135hours/semester) internships require additional participation, written outreach materials, and program leadership.

#### **Focus Option Descriptions:**

- 1) **Green Events:** Collaborates with event planners across campus to create zero waste and sustainable events, helps to organize annual events such as Earth Day, and leads monthly creek clean-ups.
- 2) **Real Food Nourishment:** Works with AS foodservice to reach a goal of providing 20% Real Food by 2020. The focus is to enter and analyze purchasing data, research product shifts, as well as communicating the importance of nourishing food to the campus community.
- 3) **Education and Outreach:** Strives to increase awareness and action by organizing interactive workshops, tours, field trips, and campaigns.
- 4) **Graphic Design and Media:** Promotes the activities of the center through the creation of posters, video, event design, and social media.
- 5) **Compost and Garden:** Manages the AS compost and garden area as well as hosts workshops, field trips, and volunteer days.
- 6) **Sustainability Fund:** Hosts grant workshops, manages finances, and performs administrative duties in support of the student sustainability grant program.

# **Student Learning Objectives**

- Become familiarized with sustainability efforts on campus, within the AS, and in Chico
- Become engaged in the solutions to environmental problems
- Use and think about current research when implementing environmental solutions and creating outreach materials

- Develop an understanding of how to turn intention into action
- Practice the steps and processes of organizing a project, activity or campaign start to finish
- Develop productive relationships with peers and staff
- Think critically and be creative
- And to provide students with leadership and public speaking opportunities

# **Course Requirements**

The following outlines the requirements to complete the one- unit course:

- Attendance at three All Intern Meetings and weekly program meetings
- Specific requirements based on focus option
  - o **Green Events:** Participate in greening campus events, assist in planning earth month activities, consult with event planners, host creek clean-ups, and manage the hydration stations.
  - Real Food Challenge: Become trained in entering purchasing data into the database, research
    product shifts, and create one educational display or lead an activity related to sustainable food
    systems.
  - o **Education and Outreach:** Help organize Earth Month, lead DIY workshops and field trips, and participate in tabling activities.
  - o **Graphic Design and Media:** Create one event or campaign poster, create one visually engaging tabling display, and create impactful posts on social media outlets.
  - o **Compost and Garden:** Create one hot compost pile, give one field trip presentation to a CSU, Chico class, host a volunteer work party or workshop, and help maintain the garden.
  - o **Sustainability Fund:** Assist with three Sustainability Fund workshops, create project highlight brochures, and learn and practice the fiscal management of individual project funding.
- Participation in the Sustainability Center's broader efforts:
  - o Earth Day (2 hours)
  - o Compost garden work day (2 hours)
  - o Tabling outreach (4 hours)
  - o Class talks (4)
  - o Diversion Excursion (2 hours)
  - This Way to Sustainability (2 hours)
- Research paper (2-5 pages)
- Reflection survey
