  - A. <u>Information item: Revisions to AS Corporate Codes: BMU Marquee Policy, including title change to AS Digital Advertising Policy, as presented (attached, page 5).</u> Grivette Recognized Anna Paladini. Total expenses for the year are sitting around 19%, which is great.
