- B. Information Item: Activity Fee Budget vs Actual March 2025 Director Wright explained the AS Activity Fee budget and the significance of the fiscal year starting on July 1 and ending on June 30. She recommends that the committee familiarize themselves with this report as it will come to GAC quarterly and for the purposes of this report, we will aim to be at 75% of the 25/26 fiscal year. Student Affairs is also prepping to host the Fall welcome for this year. They are sending staff to the CSU counselor conference, which is focused on providing help and information to highschool counselors.
