- I. CALL TO ORDER The Chair, Schwartz, called the meeting to order at 12:02pm
- **II. MECHOOPDA LAND RECOGNITION** The meeting started with the reading of the Mechoopda Land Recognition Statement.

- VI. PUBLIC OPINION Limited to items on the agenda, three minutes per speaker, nine minutes for entire topic Fozo wanted to address the Chat GPT rollout and some worries on campus. Chat GPT uses more water and energy than other search engines, which may go against Chico State's values regarding sustainability. She then called for the potential rollout to consider this.
- **VII. STUDENT ACADEMIC SENATE (SAS) REPORT** Action Items forwarded to the Government Affairs Committee from the Senate stand approved unless overturned by a 2/3 + 1 Committee action.

    - <u>SAS Actions: Approval of 4/3/25 Student Academic Senate agenda</u> Kachiwala stated SAS talked about the new academic models for Academic Affairs. They also showed what the next steps are for students to get involved.

### VIII.BUSINESS

A. Discussion Item: Division of Information Technology Chat GPT Rollout (Time Certain: 12:00-12:30) Monique Sendze stated April 15<sup>th</sup> is the rollout date to give licenses to all stateside students, faculty, and staff. It may take a few days to implement. There will be an immersion day in Sylvesters that allows people to test the tool at 9am through 5pm on April 15<sup>th</sup>. Students are encouraged to reach out with questions or comments to <u>doit@csuchico.edu</u>. Sendze also wanted to discuss recently published guidelines for AI. She stated the guidelines are available on the website as the GenAI Guidelines. Schwartz asked if training was required to get access to the tools, to which Sendze stated no. Schwartz then asked for the PowerPoint slides to be reviewed. The slide about electronic waste in particular was examined, and Sendze stated the amount of waste is negligible compared to the amount of waste already being generated by Microsoft equipment. Sullivan thanked Sendze, then asked why now for the rollout of ChatGPT. Sendze responded that the Chancellor's Office wanted it rolled out ASAP as they've already paid for the licenses. Gowda asked if there would be an increase in plagiarism and how an investigation would work with AI. Sendze stated the AI guidelines have a section that focuses on academic integrity. White referenced the next slide, about environmental impact and the only article linked on the slide that had a more laid-back approach to impacts. Sendze said the website has more information available. Sullivan wanted to know if there was training on how to cite AI sources, and Olguin confirmed that they teach students how to go in-depth with that in training. Schwartz wanted to know if his ideas were protected under this AI, to which Olguin confirmed they don't have access to chat history without a public records request. Schwartz then asked if they could see what was being entered and it was confirmed this could not be seen. Schwartz then asked how they could ensure guidelines were being followed, to which Olguin stated they are doing education and training as best they can to ensure this. Anderson left the meeting at 12:44.
