VII.BUSINESS ITEM

A. Information Item: University Housing Room and Board Fee Increases Corinne Knapp from University Housing came to notify the committee that room and board fees are increasing. Due to rising costs, the only solution to continue providing university housing was to increase the cost of on-campus housing. Chico State now ranks 18th out of the 23 CSUs for average housing cost. The total increase will be approximately 12.48% to ensure sustainable funding. They also asked for a 6.95%-12.07% increase for the 2025-2026 academic year, and the final amount is to be determined based on wage increases, utilities, etc. The rate increase requested was to be able to maintain and operate all university housing, and so that University Housing did not have to draw from reserves. The increase will benefit students by having increase flex cash and meals regarding the meal plans that are included with university housing.
