**I. CALL TO ORDER:** Meeting called to order by Arisman at 9:11 am.

### **VII. BUSINESS ITEM**

A. Information Item: Brainstorm with Information Technology about New Mobile App  
Scott Kodai joined the meeting to discuss new opportunities within the Division of IT. They are launching a new mobile app sometime in July. They would like to integrate Canvas and Peoplesoft within the app to make it useful for students. It will also include an emergency notification system and a calendar of events going on across campus. (Landry joined the meeting in-person. He was previously on Zoom.) Boggeln mentioned he liked the integration of other campus used apps. He mentioned the possibility of integrating CatsConnect and the WREC app. Kodai mentioned having a system where it would automatically launch other apps that students use, like the WREC app. Arisman asked if the Chico State Portal would also be included. Kodai mentioned wanting to replace the Chico

State Portal app with the new mobile app. Landry mentioned having a map of campus within the app. Kodai mentioned it will already be integrated. Vazquez mentioned the opportunity of having a digital ID card for students within University Housing. Kodai said that this is already something the IT division has thought about and may implement in the future as a separate entity. Parella said as she is an AS dining employee, having a digital ID would be nice. Kodai said the cost of a digital ID does cost slightly more, and that currently they do not have the budget to accommodate it. Kodai mentioned wanting to have the app be a seamless experience for Chico State students, and have the notifications be relevant to the students. Arisman mentioned this could be a continued conversation with next year's elected representatives. The conversation transitioned to how the Division of IT could gather student feedback. Arisman mentioned in the past there have been surveys that have been created and sent out to students via the Student Senators. Kodai mentioned liking the idea. He also mentioned there will be a polling feature built into the app that could be used to gather student feedback. Arisman mentioned talking to Kendra Wright about forming a subcommittee to help provide feedback. Machado asked if Handshake could be integrated as well as students being able to receive job alert notifications for jobs that students are interested in. Kodai said the Handshake app will be included in the beta version, and said there is a possibility of integrating push notifications if the Handshake app already allows it.
