I.CALL TO ORDER - Chair called the meeting to order at 02:03 pm

II.MECHOOPDA LAND RECOGNITION: The meeting started with a reading of the Mechoopda Land Recognition.

- VI. BUSINESS -

b. Gowda elaborated on the submitted form & the images provided by them for the Multicultural Fashion Show & the mixer following it.

c. Discussion Item: Cultural/Heritage Awareness Displays- Gowda explains the planned themes for the table displays for next months. Kendra suggested dividing the table in half for Black history month, & Pandit added that we can divide the rest of the table for Resources & Upcoming events. Gowda informs that the table should be set up before Feb 1st & expects the voting members to volunteer to pitch in 1 hour anytime throughout the week to help set it up according to their schedules & availability. The present voting members volunteered their time according to their respective schedules & the non-voting members explained their remote availability.

She also informed about First program which will help students build confidence & encourage them to apply for leadership positions in various clubs on the campus through talks by various presenters, including Sullivan.
