## RESOLUTION FOR A FEASIBILITY STUDY OF THE ENERGY CONSERVATION ADVISORY MEASURE

WHEREAS, In the Spring 2007 elections, two energy conservation advisory measures were approved. The following measure was approved by 81.3% of the voters, and read:

"In order to save money, keep fees down, and help the University meet its goals of conserving energy and reducing greenhouse gas emissions, should the Associated Students encourage the University to adjust the current heating and cooling standards by 3 degrees so that University buildings will not be heated above 65 degrees or cooled below 81 degrees?"; and

WHEREAS, According to the U.S. Department of Energy the cost of energy will continue to increase; and

WHEREAS, Facilities Management and Services (FMS) has reported that the University spends more than half a million dollars annually on heating alone; and

WHEREAS, By using the formula derived by Arizona State University, the energy savings by changing three degrees in cooling alone is estimated at 2,544,960.681 kWh, which is equivalent to \$152,697.64; and

WHEREAS, One of the six strategic priorities of California State University, Chico is Sustainability; and

WHEREAS, This measure should improve campus sustainability; and therefore be it

RESOLVED, That the Associated Students encourages the California State University, Chico Academic Senate to request that the University conduct a feasibility study and cost analysis in consideration of the three degree change in both cooling and heating; and

RESOLVED, That the Associated Students encourages Academic Senate create and implement a survey to staff, faculty, and students following the experimental three degree change and prepare a report with FMS including both the result of studies and the survey; and

RESOLVED, That this resolution be widely distributed by electronic means to the President's Cabinet, Academic Senate, Deans, Department Chairs, faculty, staff and students of California Sate University, Chico in addition to the California State Student Association (CSSA).
