- A show/ artist profile on the Gallery website during the run of the show.
- Design services from AS Marketing for custom poster, postcard and digital promotional assets.
- Printing and mailing of an announcement to our select mailing list, plus an additional 75 announcements and 25 posters to be mailed/distributed at the artist's discretion.
- Assistance with the installation/de-installation of works online or in the gallery space. Please note artists are required to utilize the Gallery hanging system for their installation in the gallery space.
- Reception in the Gallery

**Exhibiting artists must provide the following:**

- Images of works for use in online artist/show profile, announcements and posters.

- Transportation of all work to and from the Gallery.
