The Internship Fair gives CSU, Chico students a chance to meet the GSEC staff and learn more about what the internship entails. Applications for the internship are available for the Women's, Queer, Trans, and Outreach Programs. **Please join the GSEC on Thursday, January 25 from 5:00–6:30 p.m. in BMU 004 and find out what working at an activist organization can do for you!**

The Internship Fair provides an opportunity to network with fellow student leaders and activists on CSU, Chico's campus. The GSEC is looking for students who are passionate about promoting social equity and motivated to work toward inclusion of all marginalized identities on our campus and in our community. The GSEC staff will explain the application process, requirements for the internship, and the seminar course (MCGS 489) that all interns must take. This is a great opportunity for applicants to ask questions and see which program they would like to intern with. Snacks and beverages will be provided.

The intern positions advertised in the Women's, Queer, and Trans Programs will aid in planning and organizing events that positively impact the Feminist and LGBTQ+ social justice movements. Outreach interns will promote those events with print and digital marketing. Anyone with a passion to join in on these efforts in educating our community on the importance of social justice issues is encouraged to apply.

No previous experience necessary. Applicants must be available on Mondays from 5:30-7:30 p.m. for GSEC's weekly meetings and on Thursdays from either 11:00 a.m-12:50 p.m. or 5:00-6:00p.m. to attend one of the MCGS 498 courses that coincides with the internship. The GSEC would prefer that interns would sign up for the 5:00 p.m. MCGS 489 course unless absolutely unavailable for that time.
