- Written statement including a description of the work to be exhibited
- Pictures of work to be displayed. Please provide pictures on a CD or Flash Drive with pertinent information for each image, including title of work, medium, orientation mark, and dimensions.
- Self-addressed stamped envelope (9" x 12"). The 3rd Floor Gallery will not be responsible for the return of proposal materials without a self-addressed stamped envelope.

If your proposal is accepted, the Gallery will provide the following:

- Gallery space on the third floor of the Bell Memorial Student Union
- A printed and bulk-mailed announcement to our select mailing list, plus an additional 75 announcements and 25 posters to be mailed/distributed at the artist's discretion

- Assistance with the installation/de-installation of works. Please note that artists are required to participate in this process.
- Opening reception in the Gallery

Exhibiting Artists Must Provide the Following:

- Images of works for reproduction on the announcements and posters
- Transportation of all work to and from the Gallery; The 3rd Floor Gallery is not responsible for any transportation costs.
